Resolution on the Cultural Institutions in Al-Quds Al-Sharif and the Arab occupied territories

The 4th Islamic Conference of Culture Ministers, held under the high patronage of His Excellency Mr. Abdelaziz Bouteflika, President of the People's Democratic Republic of Algeria, in Algiers, on 3-4 Zul Qi'da 1425 A.H. / 15-16 December 2004,

- Taking into consideration the condition into which the educational, scientific and cultural Institutions in Al-Quds Al-Sharif and in the Arab occupied territories are degenerating, regardless of their number and competence,

Decides the following :

1. **Affirms** its solidarity with the Arab people in Palestine, Syria and Lebanon, and its support for putting an end to the Israeli occupation of Al-Quds Al-Sharif and the Arab territories, with a view to enabling the Palestinian people, in particular, to exercise its national and political rights, and enjoy full freedom, dignity and independence in managing its affairs and establishing the emancipated State of Palestine with Al-Quds Al-Sharif and its capital
2. **Strongly condemns** the aggressive practices of the Israeli occupying forces in Al-Quds Al-Sharif and the occupied Arab lands, as well as the occurrences of spoilage of the ancient monuments and cultural properties, and the destruction and disfigurement of historical landmarks; and **calls upon** the international community, especially the concerned regional and international organizations, bodies and institutions, to make a swift move to halt these unjust practices, and to work with all available means, and within an international cooperation, towards extending support to the said cultural institutions.
3. **Declares** the commitment of the Member States, through the Islamic Educational, Scientific and Cultural Organization –ISESCO–, to proceed with their support to the National Palestinian Authority and to the competent bodies in Syria and Lebanon, with a view to saving their educational, scientific and cultural institutions, and to resetting them in operation so that they could discharge their mission in terms of upgrading culture and promoting the efforts of comprehensive development.
